I have personally designed and created the tribal website, social media accounts, PayPal, etc., myself in order to carry out Missionary duties as expressed on the Ammuurian Tribal Website, propagating the faith and to extend the learning and truth of the Great Prophet Noble Drew Ali to the Natural Peoples of the Land by The Prophet Holy Instructions. This unintelligible, unlawful command, and or claim coming from the "Chambers," of acting Official "Royal Bey" **Mustafa El Tarik Bey et alia Troy Franklin Bey**, and bearing NO Principal Signature.

Notice of Estoppel and Relief of Service

8/12/2019 Nunc Pro Tunc

To: Judah Bey

You are hereby ordered to **Cease and Desist** all actions immediately concerning the trustee affairs for the Ammuurian Tribe.

Lawful Release

All journals, ledgers, book keeping entries, account logins, accounting, receipts, bank accounts, cash app accounts, PayPal accounts, applications stored in your database, sign in sheets, hard copies of applications, all payment profiles (active, suspended and cancelled), Ammuurian Tribe Property (projector, seals, stamper, embosser, receipt book, and any other property in your possession) release all account information for social media platforms to include passwords, and return the funds collected to the Ammuurian Tribe currently in your possession; this is commanded within (24) hours upon receipt of this Order for the succession of this station for the next predecessors to carry out the necessary duties and functions of said station. The initial agreement that took place on the date of (July 26, 2019) between the Trustees to do the RESET dated for August 1, 2019. This agreement included changing the Language on the Website to reflect what was agreed upon during the meeting, the changing of the amount of dues and how they will be collected, and rendering access to the website. After August 1, 2019 this agreement was not adhered to and carried out on your behalf. To the contrary you changed the wording to that of your own and not what was agreed upon by all trustees, you continued to collect finances passed August 1, 2019, and these actions constitutes a breach. Also, be sure to notify tribal members that all accounts will be shut down and you are no longer accepting payments at this time. Annul all communications on behalf of the Ammuurian Tribe immediately.

Relief of Duties

The Ammuurian Tribe deems it best to stick to protocol for the election/ appointment for the specific official position for the Trustee/ Secretary of State. There are no official documentation for the record and on the record granting Lawful Delegated Powers to act on the behalf of the Ammuurian tribe in the form of a Commission Letter, Oath of Office, Tribal Oath, Application, Delegation of Authority Order, and Insurance Coverage (Liability Insurance) by you Judah Bey. Therefore you are hereby relieved of duties in accordance with the Holy Koran, The Divine Constitution and By-Laws, Common Law, and, Divine Law and the Law of Nations CEASE and DESIST!

The above "*Notice of Estoppel and Relief of Services*" letter was sent to me by Mustafa Bey holds no Principal Signature, therefore is unlawful, feudal, de facto, and shows lack of incompetence upon the part of Mustafa El Tarik Bey et alia Troy Franklin Bey and his rush to judgement as he has no interests.

This Estoppel Letter was not in accordance to 'Due Process Rules,' which is a consistent with particular members to include **Isaiah El et alia Isaiah Boone El**, acting as Vizier/Wazier of the Ammuurian Tribe where there is a reference to "Protocol," but the action of the "Protocol" administered by the Legislature of the Ammuurian Tribe, was never fulfilled and even breached. See (*First Clause of the Ammuurian Tribal Protocol*)

"If a member / member of the tribe should find there is a breach of trust, breach of duty, the accusing member/ members should first discuss in person the matter with the member or members that allegedly breached the trust or breach the duty"

On or around December 10, 2018 I had a conference call with **Isaiah El et alia Isaiah Boone El** and Noble Quibian Naseer El about the establishment of Tribal nation to help restore the Moorish Empire here at North-West Amexem and all of the Dominion Empire. Isaiah El discussed how he started a study group with other Moors who were no longer building and working with him due to undisclosed issues that were taking place within the said study group. Isaiah El would frequently bring up the online website "Read Moor About It" which was supposed to be created to provide as an online press for Moorish Americans per a credible national teacher, leader, and elder. Never once was mentioned to design and build an online presence for the actual new study group. As we would continue to converse over the uplifting of fallen humanity, I would mention the possibility of building such a presence for the new study group and expanding it across all of Amexem and actually establishing an online "Tribal Nation" to help bring awareness about the new study group that included Isaiah El, Noble Quibian Naseer El, and now myself including a few other Moors in the Maryland Republic near the Baltimore territory. It was expressed during this call that we didn't need an online presence for the new study group (Ammuurian Tribe). This was expressed by both Isaiah El and Quibian Naseer El.

I then took it upon myself to design and build the "Ammuurian Tribe" website with my own energy and financing. I also purchased all domain names with my own energy and financing to include ammuuriatribes.org, ammuuriatribes.com, and ammuuriatribes.net. I would also create and establish the Ammuurian Tribe's presence via social media to include Instagram, Facebook, and Twitter. I took my vacation time from my "job" to create and build the Ammuurian Tribe website. For about the first week nobody knew I was building the website as I wanted to offer the site as a surprise to both Noble Quibian Naseer El and Isaiah El (and to prove the need for an online presence). During the creation of the website I would use my time away from my kindred, and without pay and no signed contracts with any tribal members including Isaiah El, to research and conduct website audits on various governmental and tribal online platforms from around the world. This process was done through an eight (8) step content visibility strategy (CV8) that I created for my digital marketing agency, which I also co-founded with Quibian Naseer El (digital marketing agency is still operational and generating finance). I have been studying Moorish Science, along with Law and Civics, for the past six (6) years so I have to concepts to write website content for the tribe (please reference my Instagram account; @moorish.divine). Myself,

along with Noble Quibian Naseer El, also co-founded *Moorish Science University - MSU* (please reference our Instagram account; @moorish.science.university) where we held our first class last year on May 31, 2018, along with another Moor (undisclosed), before temporally abandoning the MSU project to focus on our new project, the Ammuurian Tribe. I would fund, with my own energy and financing, the online video software (We Video) to create the various videos used as backgrounds on the Ammuurian Tribal website. I would research the right content to express what we wanted to establish as a Tribal Nation. I wrote vast majority of the website content utilizing content audits, research, and target audience sequencing, and followed up by the actual writing of the website content. Writing website content is very much different than writing writs and affidavits. Writs and affidavits are generally "technical" writing styles as web content needs to speak to the passion and pain points of your target audience so that your audience will take the desired action necessary. Writing brand stories is critical to an effective content strategy which only I had the skill set to do. I have been building websites and writing website content for approx. 15 years. I have worked with many small local businesses, as well as Fortune 100 companies, on various online projects throughout the years. The goal is to "know your audience" so that your content speaks to them directly. Website content should allow your target audience to become the hero of your brand stories, thus allowing your target audience the ability to solve their own problems by providing their own solutions! (See attachments 1 & 2 below)

During the last week of creation (as it took me approximately two weeks to complete) I would show the website to both Noble Quibian Naseer El and Isaiah El. They both were extremely excited about the website. I would also consult with both Noble Quibian Naseer El and Isaiah El on the Allodial language on portions of the website content that I had previously researched and produced. I would also consult with Quibian El and Isaiah El on the Allodial language of membership dues and offerings before the releasing of the website to the public. Another Tribal member (undisclosed) would assist me with the 'Departments' page of the website. About 90 to 95 percent of the content written on the website, along with the design elements and software functions, are from my contributing energy, intellectual properties, and financing from my own pocket. My time, knowledge, energy, and financing for designing and creating the Ammuurian Tribe website, and with no signed contracts ever, is a small portion of my contributions to The People and the uplifting of fallen humanity.

During this time of me building and completing the Ammuurian Tribe website, I had a private phone conversation with **Isaiah El et alia Isaiah Boone El** concerning my nationality paperwork being sealed, witnessed, and returned back to me. The conversation was about how my consort was concerned that my three year old daughter didn't have health insurance because we decided not to apply for her (my

daughter) to have a social security number and birth certificate. I explained to Isaiah El that my consort was very worried at the fact that our daughter didn't have health insurance with her being so young (only three years of age) and that if something tragic was to happen our daughter wouldn't be covered. We discussed the remedies that we could explore and Isaiah El then told me that he would in fact witness and seal my nationality paperwork, along with Live Birth Record to send to health insurance agency per their request for validation. In fact, a parent's worst nightmare came true when my three (3) year old daughter was admitted into the hospital for having fluid in her lungs. I expressed this, to who I thought was my brother, Isaiah El. I truly needed my paperwork as we were in dire need.

Days and then weeks would pass and I still didn't receive my nationality paperwork for myself and kindred, along with Live Birth Record. I would have another phone conversation with Isaiah El and was told that "Smith-Bey" had my paperwork and "Smith-Bey" would be sending the paperwork back to me. I never spoke with "Smith-Bey" and I never received my nationality paperwork as promised by Isaiah El. I'm not sure why Isaiah El passed the responsibility off to "Smith-Bey" when in fact it was Isaiah El that said he would personally witness and seal the paperwork and return it back to me. Isaiah would soon leave for a week vacation to India and would return approximately January 23, 2019.

At this point I decided to contact Noble Quibian Naseer El and explained the situation and my concerns and frustrations concerning Isaiah El promising my nationality paperwork before his departure to India. I explained that my three year old daughter doesn't currently have health insurance (because we declined to sign a birth certificate and social security number) and the health insurance company was looking for proof of birth, so my daughter's hospital bills would be paid in full by said health insurance agency. My consort and I explained to the health insurance personnel that we had a Live Birth Record and would fax it once we received it back from being witnessed and sealed. I expressed to Noble Quibian Naseer El that it has been several weeks that I've not received the documentation promised by Isaiah El. Noble Quibian Naseer El would apologized on the behalf of Isaiah El and somewhat felt responsible as Noble Quibian Naseer El personally introduced me to Isaiah El. Noble Quibian Naseer El stated that he didn't have access to retrieve my documents or he would send them off himself. He went on to say he would personally contact Isaiah El himself once Isaiah returned from his vacation from India. I would also express my concerns as the acting "Secretary of State" towards the acting "Vizier/Wizier" Isaiah El.

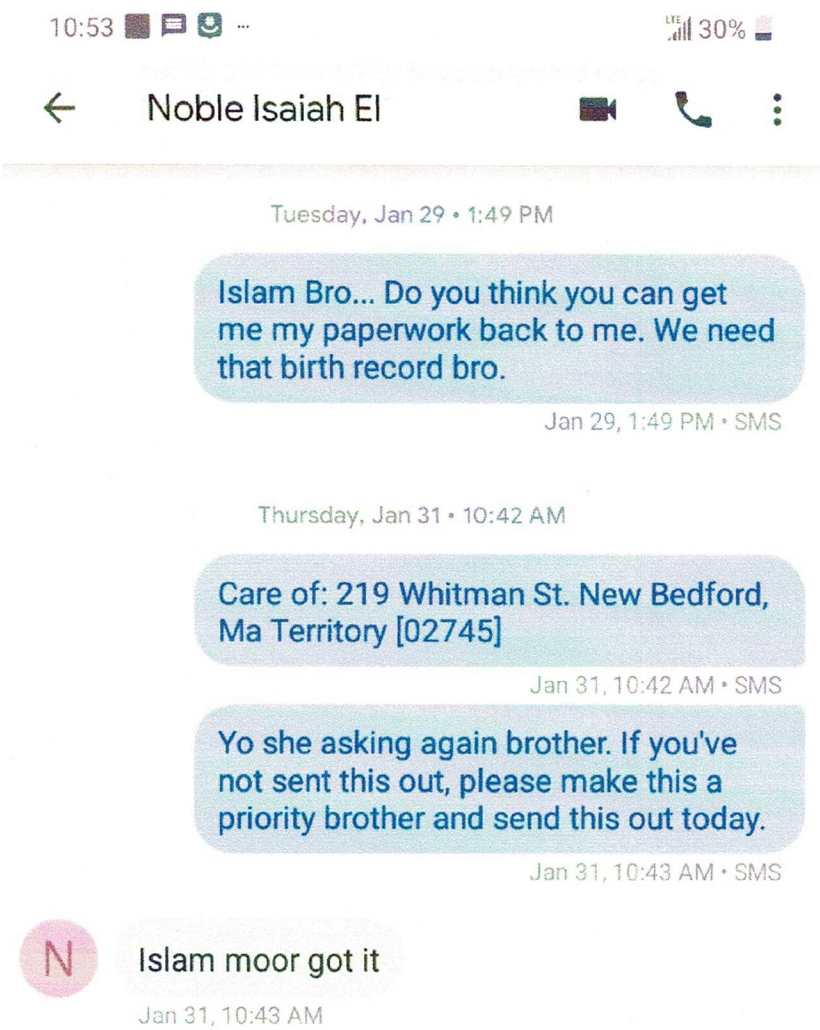
I stated to Noble Quibian Naseer El that I questioned the integrity of Isaiah El and his maturity level to be a leader and the face of the Ammuurian Tribe. I mentioned the empty promises concerning my nationality paperwork due to the fact that it was my personal energy and finances that actually created the Ammuurian Tribe online platforms and willing to help Isaiah El become the Noble man he desired to become for the Tribal Nation and Moorish Divine and National Movement. I was selfless with my finances, time, knowledge, and energy when designing and building the online Ammuurian Tribal platform and Isaiah El could not commit to sending out my nationality paperwork and Live Birth Record as my kindred was in dire need to those documentations.

I would also correspond with **Isaiah El et alia Isaiah Boone El** via SMS text message concerning my nationality paperwork asking if he (Isaiah El) can return my nationality paperwork once he returned from

India. I texted this message to Isaiah El on January 29th, 2019 after making a phone call to Isaiah El in which he didn't pick-up. I didn't hear back from Isaiah El so I sent him another SMS text message on January 31, 2019 giving him my domicile, just in case he didn't have it for some reason and this could be the reason why I haven't received my nationality paperwork. In the message, I also explained that my consort (remain anonymous) was asking me again about the delivery of the signed and sealed paperwork, and if he (Isaiah El) has not done so and to make it a priority and to do it today. My consort was getting highly upset at this point and she was distressed in the process. Isaiah El finally responded back via SMS text message saying "Islam moor got it." (See image #1 below) I still never received my nationality paperwork at this time from Isaiah El.

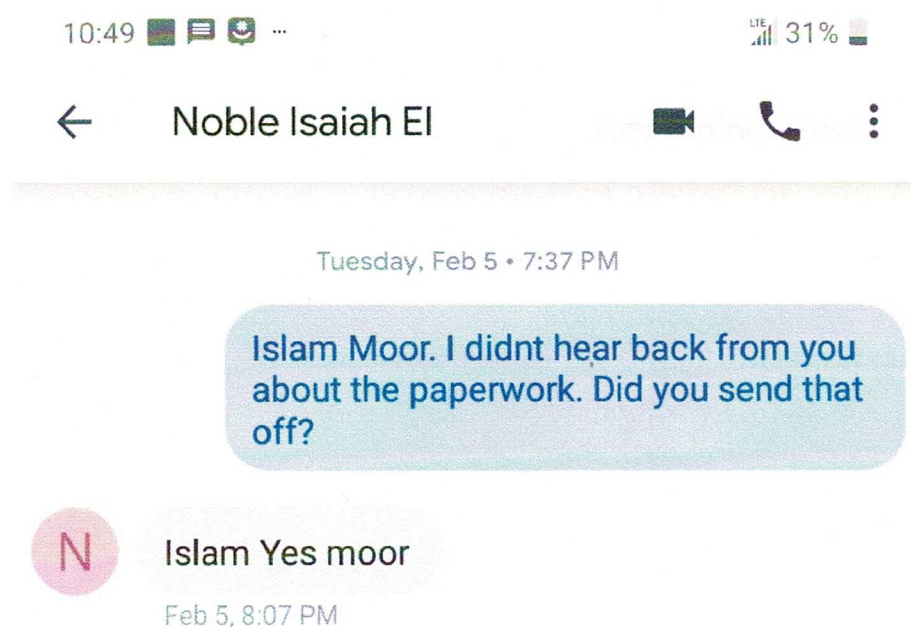

Finally, on February 5th, after not hearing back from Isaiah El, I sent him another SMS text message stating that I never heard back from him about my paperwork and if he sent it off. Isaiah El responded via SMS text message saying "Islam Yes moor." (See Image #2 below) Again, I never received my

paperwork during the timely manner that was promised by Isaiah El.

As my frustration mounted, concerning my nationality documentations, I encouraged Noble Quibian Naseer El to set up a conference call between myself, Isaiah El, and Noble Quibian El to iron out any concerns and/or issues. During this time Noble Quibian Naseer El was like the glue of the Tribe. He would make sure members were attending classes by sending out text messages, he was the acting "Treasurer" for the Tribe; he would also assist with judicial duties, etc. It was in fact Noble Quibian Naseer El that created the initial momentum to keep current Tribal members motivated through his transparency. I expressed my concern to Isaiah El about never receiving my documentations during the conference call and was not sure of the vision of the Tribe set forth by Isaiah El as the acting "Vizier/Wizier" for the Ammuurian Tribe. Isaiah apologized and stated that the documents were sent out and had returned back to him for some apparent reason. This statement appeared to be an excuse that I cannot prove, yet it was Noble Quibian Naseer El who would finally get my documentations from Isaiah El by literally going to his house and would send to me about a week later Taxe Percue (Postage Paid).

For me, the lack of accountability concerning my nationality paperwork truly showed the maturity level of Isaiah El and his inability to be a leader for the Ammuurian Tribe. I was willing to be patient and allow Isaiah El the ability to personally grow into this acting role of "Vizier/Wizier." I knew that Isaiah El was young (26 solar returns) and he had no kindred of his own and was not raising (children). I questioned his ability to handle pressure in such a position as the acting "Vizier/Wizier." This was also a conversation I had with Isaiah El in private on a separate phone conversation. However, I gave Isaiah El the benefit of doubt and continued to show patients and gratitude for this young brother throughout the coming months,

although he would continue to display his immaturity level to handle such a position within the Ammuurian Tribe.

During the early hour of June 24, 2019 at approximately 12:06 AM Eastern Standard Time, I received a call from **Mustafa El Tarik Bey et alia Troy Franklin Bey** in which I missed due to me travelling back from my "job." I also received a back-to-back call from **Isaiah El et alia Isaiah Boone El** at 12:08 AM Eastern Standard Time. I was able to speak with Mustafa Bey, Isaiah El, and **Atonya El et alia Atonya Boone El**. These three (3) Moors stated for the record that they would like for me to lock Noble Quibian Naseer El out of the PAYPAL account due taking 200 FRNs (private commercial papers) from the PAYPAL account unlawfully. Please keep in mind that the 200 FRNs (private commercial papers) that Noble Quibian Naseer El withdrew from the PAYPAL account was in fact his lawful finance as he had loaned the finance to the Ammuurian Tribe so that we may secure a nationality card machine so that we may assist The People (which they are still fraudently holding til this day).

Mustafa El, Isaiah El, and Atonya El all agreed that Noble Quibian Naseer El could in fact withdraw his finances from the Ammuurian Tribal PAYPAL account, but was looking for three (3) signatures before the withdrawal. The finances (200 FRNs or private commercial papers) of the Ammuurian Tribal account balance within our PAYPAL account did belong to Noble Quibian Naseer El and he was in dire need of his finances so that he could take care of his cherubs. As the acting Treasurer (in which I entrusted Noble Quibian El holding such a Title) that he was acting in an honorable fashion. During the call on June 24th 2019 with Mustafa Bey, Isaiah El, and Atonya El they highly encouraged the lockout as they didn't want Noble Quibian Naseer El to have access. I stated for the record that such a decision could not be made without Noble Quibian Naseer El on the phone call.

To the credit of Mustafa Bey, Mustafa tried calling Noble Quibian Naseer El three (3) times to no avail. I stated again for the record that I didn't feel comfortable having such a discussion and restricting access of the PAYPAL account if Noble Quibian Naseer El was not on the phone call to at least defend the allegations with no Proof coming from Mustafa Bey, Isaiah El, and Atonya El. They would convince me to comb through the PAYPAL transactions in which I did and found nothing at the time. It took about one hour to look through the transactions, and again, found nothing at that time.

I also asked Isaiah El and Atonya El why they could not go through the PAYPAL transactions themselves, since they were making claims that Noble Quibian El was taking finances and withdrawing his 200 FRNs (private commercial papers) before the alleged allotted time and without the three (3) signatures; which was a brand new protocol created by Isiah El to specifically deal with this issue. There was silence when asking the question and it appeared that both Isaiah El and Atonya El didn't have the comprehension to figure out PAYPAL or didn't have the desire to learn the online banking system (PAYPAL). Isaiah El and Atonya El both had full access to all functions of PAYPAL at the time. It appeared that both, Isaiah El and Atonya El, were desperately looking to remove Noble Quibian Naseer El from the acting Treasury position for a nondisclosed reason which appeared to be ill intent on their part.

After combing through the PAYPAL transactions, and finding nothing at the time that would criminalize Noble Quibian Naseer El, it was said to me by both Isaiah El and Atonya El, that Noble Quibian Naseer

El was also taking finances from "Sunday School." I asked them both if they had the proof and they stated they did not have proof, but speculated, or "had reason to believe" that Noble Quibian Naseer El was in fact stealing the finances from "Sunday School" because he "was no longer working in his trucking business." The motive behind the acting "Vizier/Wizier" Isaiah El was dishonorable and he broke Tribal protocols by discussing such a matter without Noble Quibian Naseer El being on the phone to defend himself, and trying to remove him as acting Treasurer based off speculation and misjudgment. There was simply no proof at the time of the phone conversation with Isaiah El, Mustafa Bey, and Atonya El that Noble Quibian Naseer El was stealing finances from the Tribe. I asked if they had spoken with Noble Quibian Naseer El about the allegations and both Isaiah El and Atonya El stated yes, and each time they would ask they stated that Noble Quibian Naseer El would become emotional and would get angry as if he was trying to hide something.

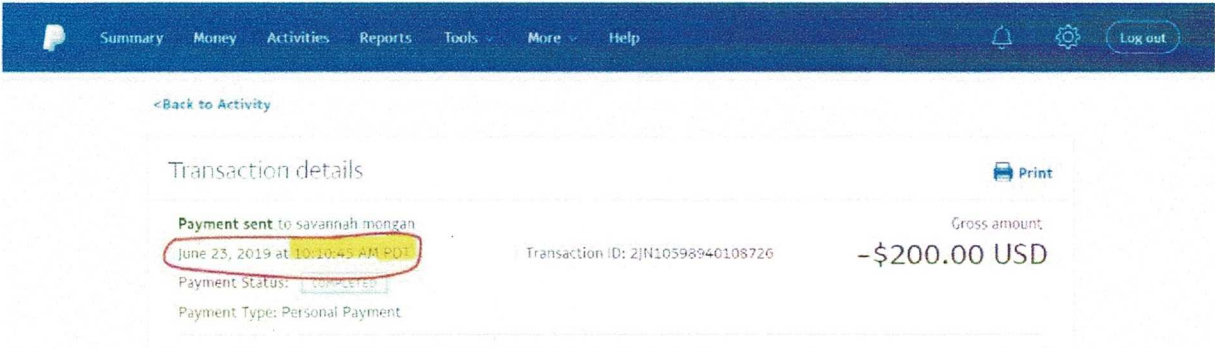
After sleeping on the subject matter that was previously discussed on the phone with Mustafa Bey, Isaiah El, and Atonya El, I decided to give Noble Quibian Naseer El a call at 11:26 AM Eastern Standard Time on June 24th 2019. I asked if Noble Quibian Naseer El if he received any missed calls from Mustafa Bey and Quibian El stated yes. I quickly explained to Noble Quibian Naseer El the nature of the previous phone call with the so-called "Trustees" (Mustafa Bey, Isaiah El, and Atonya El) and how they wanted me to restrict his PAYPAL access due to Noble Quibian Naseer El taking his 200 FRNs (private commercial papers) from the Ammuurian Tribe PAYPAL account. I also asked him if he was in fact stealing finances from the account and CASH APP and Noble Quibian Naseer El stated "No!" He then told me that he thought he was exonerated from the alleged allegations because he submitted financial reports and had another conversation with these three (3) Moors. I had no reason not to believe Noble Quibian Naseer El because I didn't find any missing finances coming from PAYPAL and you can't delete financial transactions (only archive them), and all transactions would be seen within the financial reports within the PAYPAL account.

I also explained to Noble Quibian Naseer El that Isaiah El and Atonya El appeared to be pretty upset because Noble Quibian Naseer El took his 200 FRNs from the PAYPAL account before the allotted time and without the three signatures. Noble Quibian Naseer El explained to me that he didn't have time to wait for three (3) signatures and that the finances were in fact his and that it was verbally agreed upon for the withdrawal of the funds by Mustafa Bey, Isaiah El, and Atonya El. At this point, Noble Quibian Naseer El wanted to have a conference call with Mustafa Bey, Isaiah El, Atonya El, and myself to discuss the matter and clear up any issues.

During the conference call, Noble Quibian Naseer El appeared to be hurt in regards to his feelings. It appeared that Noble Quibian Naseer El truly felt as though he was exonerated from these allegations and could not believe he was in a position to once again defend himself of stealing finances when there was NO PROOF to back the claims of Isaiah El and Atonya El. While they were discussing the issue, I was again, combing through the PAYPAL reports and found an astonishing discovery. Noble Quibian Naseer El did in fact take his 200 FRNs (private commercial papers) from the PAYPAL account at the RIGHT time as discussed. The misjudgment came when Isaiah El and Atonya El didn't realize that the PAYPAL transaction was in PDT (Pacific Daylight Time) as PAYPAL is headquartered in the California Republic

near Silicon Valley territory. (See Image #3 below)

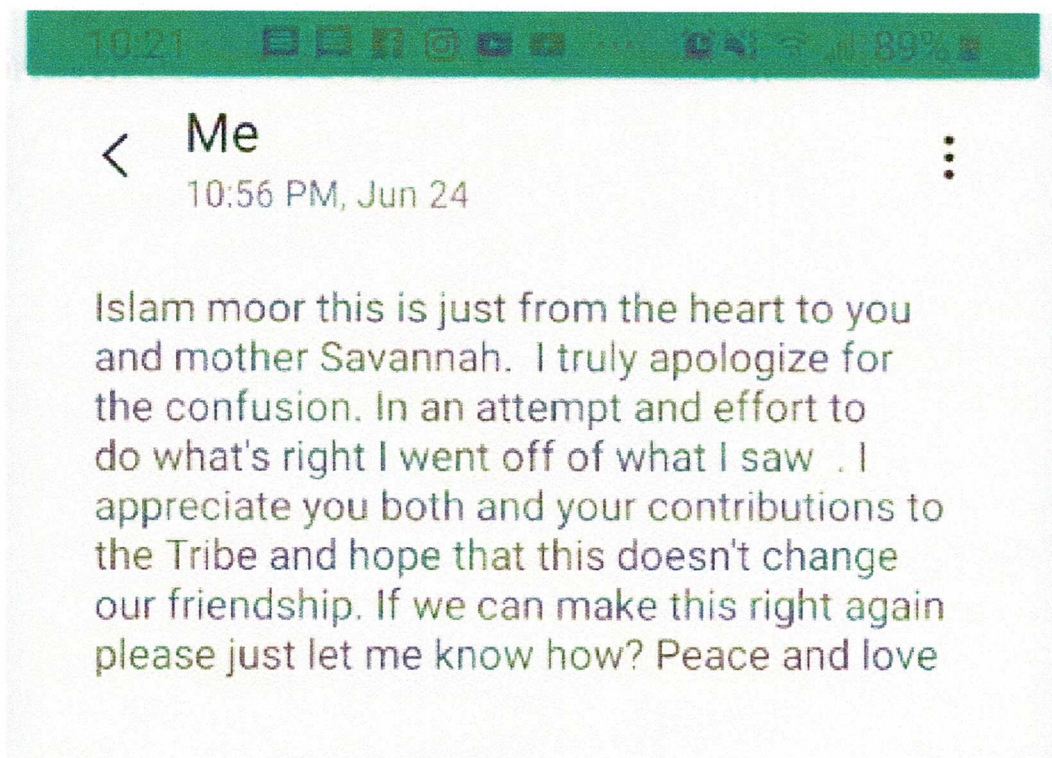
As you can see in **Image #3** above, 200 FRNs (private commercial papers) was taken out of the Ammuurian Tribe PAYPAL account on June 23rd 2019 at 10:10 AM PDT (Pacific Daylight Time). Because California is three (3) hours behind us here on the east coast, Noble Quibian Naseer El actually took the finances out at 1:10 PM Eastern Standard Time as Noble Quibina Naseer El domicile in Maryland Republic near Baltimore territory. This would mean that Noble Quibian Naseer El did in fact take the finances as agreed and confirmed by Isiah El, Atonya El, and Mustafa Bey.

The issue lies in the misjudgment and incompetence of these three (3) Moors to quickly rush to judgement without clearly investigating the facts. Once I brought this truth to light, the discussion during the conference call went silent. To my amazement, nobody apologized to Noble Quibian Naseer El for the misunderstanding while on the phone call except for Mustafa Bey (who I think was pulled into this by Isaiah El and Atonya El) because Mustafa Bey never had access to the PAYPAL account and therefore truly didn't know what was going on. The issue with Mustafa Bey is that he was running off of hearsay without proof to back these alleged claims coming from Isaiah El and Atonya El; which was dishonorable on the part of Mustafa Bey.

I later found out, by having a discussion with Noble Quibian Naseer El, that Isaiah El did apologize for this misunderstanding via a text message. I was relieved, but not surprised of this. A true leader would have apologized as soon as the truth was revealed, and not waited to text the apology. This shows the immaturity level of Isaiah El and his inability to lead and take accountability for his wrongful actions. On June 24, 2019 I restricted access to both Isaiah El and Atonya El for their incompetency to utilize common sense and effectively read financial reports and transactions, in hopes to minimize confusion and bring more unnecessary harm to our dear brother Noble Quibian Naseer El.

Notice in the text message sent from Isaiah El to Noble Quibian Naseer El, Isaiah El admits that he appreciates him and his contributions to the Ammuurian Tribe. I hope in this affidavit you clearly get the understanding how much Noble Quibian Naseer El brings to the table and how much he loves The People.

To date, according to Noble Quibian Naseer El, Atonya El has not apologized to Noble Quibian Naseer El for her part in misunderstanding and bringing false claims without proof to this matter. This clearly shows her true nature and intent.

SIDE NOTE:

These allegations of Noble Quibian Naseer El stealing finances from the tribe, truly makes no sense. Let us explore what I mean. Noble Quibian Naseer El has been contributing monthly finances in the amount of 36 FRNs (private commercial papers) since January 2019. (See image #5 below) He also loaned the Tribe 292 FRNs (private commercial papers) so the Tribe could acquire a Nationality Card Machine to assist The People. To date, Noble Quibian Naseer El has contributed more finances to the Ammuurian Tribe than Isaiah El (0 FRNs), Atonya El (18 FRNs), and Mustafa Bey (45 FRNs) combined.

In the above email I clearly state that it appears that Noble Quibian Naseer El has possibly "mismanaged" funds and in fact did not steal or embezzled finances as Isaiah El and Atonya El has stated. I go on to say that "It is my assessment of the reports that all PayPal finances are accounted for and that the matter be laid to rest." The inconsistency in my statement is me saying that 24.47 FRNs were in fact "unaccounted" for which was true in my comprehension at the time. However, I did not say this to criminalize Noble Quibian Naseer El or to "collude, conspire, and aid and abet in these dishonorable actions" stated by Isaiah El.

Why would I need to collude, conspire, aid, and abet with Noble Quibian Naseer El on such a low amount of 24.47 FRNs, or any amount for that matter? If I needed 24.47 FRNs I'll simply go to my personal account and withdraw the amount, or find a client who needs website or digital marketing services. On August 1, 2019 we had a "Trustee" call to discuss the direction of the Tribe. We spent approx. four (4) hours on the call trying to come to resolutions and solutions to better serve our Tribal members. It was said on the call by Isaiah El, Atonya El, Mustafa Bey, along with another acting Trustee (undisclosed) but

not to include, Noble Quibian Naseer El, which they wanted to cut off access to all Moors outside of the Maryland Republic and Virginia Commonwealth. (Isaiah El, Mustafa Bey, and Geana El have gone on the record to confirm this when releasing a slander YouTube video on August 31, 2019 entitled “The Ammuurian Tribe Officials: Caveat, Breach of Trust”)

During the conference call, many topics were discussed but most importantly we discussed the monthly contributions (dues) in the form of automation via PAYPAL, the reduction of dues, access to the Tribal website for changing of content, and accessing CASH APP, INSTAGRAM, YOUTUBE, and FACEBOOK accounts that were all being controlled by myself and Noble Naseer El... for obvious reason laid out in this Affidavit of Fact and Statement of Truth.

In my truest opinion, the conference call that took place on August 1, 2019 was a complete waste of my time, knowledge, and energy. However, I was able to confirm on this phone call with all acting “Trustees” that certain members lacked the skillset and insight to, not only lead me, but lead The People in a forward direction. I truly started to question the integrity and intent of these Moors (not to include Noble Quibian Naseer El who has always remained in honor).

There was a lot of confusion on the conference call as to what direction the Tribe should be going towards. We initially created the Ammuurian Tribal website to bring knowledge and remedy to the people across all of North-West Amexem (North America) and the Dominion Empire, as “Your Remedy is Our Unity” which in essence also means “Our Unity is Our Remedy.” It was Mustafa Bey, Atonya El, Isaiah El, and an undisclosed acting Trustee to want to close off access to all of North-West Amexem. This in fact was a breach as there has been contributing Tribal members donating their monthly dues and who domicile outside of these territories.

When these Moors (Isaiah El, Atonya El, and an undisclosed acting Trustee) wanted to close off access to all of North-West Amexem and not assist Moors outside of the above mentioned territories, it was Noble Quibian Naseer El that asked if we should in fact give all the finances back to those Tribal members who domicile outside of these territories, because we (as acting Tribal Officials) have not offered all of what we promised “Core Members” via the Tribal website, to include but limited to, access to the membership area, nationality cards, team leaders, etc. It was Atonya El who suggested not giving back their finances as they have “contributed” and that we would in fact use their contributions as a “cushion” because the discussion was to also remove the automation via PAYPAL. Mind you, these Moors are making suggestions and trying to make moves without financial interests into the entire platform.

During a conference call, an agreement was made that entailed a Tribal Reset dated for August the 1st 2019 that would include:

- The reduction of the dues from \$9, \$18, & \$36 Notes (Private Commercial Paper Units) to 50 cents a month.
- The cancellation of the automation from the Tribal Member's Accounts.
- Access to the Ammuurian Tribe Website that only Judah Swaggerty Bey had access to.
- Changes to the website embodying what was agreed upon during the meeting.
- Access to the CashApp, PayPal, Instagram, YouTube, and Facebook accounts that only CHRISTOPHER BARRETT EL, Quibian El et alia had access to.

The Trustees deemed it necessary to balance the scales and spread the control amongst the Trustees as it is customarily done pursuant to Common Law to have a Checks and Balance of Power. These two (Judah Swaggerty Bey and CHRISTOPHER BARRETT EL, Quibian El et alia) agreed to this Tribal Reset dated for August the 1st 2019. At the time of August the 1st 2019 the agreement was not fulfilled and correspondence via email, text messages, and phone calls ensued. The changes were not made to express what was agreed upon during the meeting, so the Cease and Desist Orders were sent to Judah Swaggerty Bey and CHRISTOPHER BARRETT EL, Quibian El et alia (See Attachement Below).

The above is a screenshot from my android phone of an email that was sent out by Isaiah El on September 1, 2019 at 2:07 AM Eastern Standard Time. The nature of the email was distasteful and flat out lies and half-truth. We know that half-truths are essentially called "white lies" so I will break down the screenshot of the bullet points and red underlines.

Bullet Point #1 – The reduction of dues was discussed as this email states. However, I never agree to reduce the monthly dues to merely 50 cents a month. Keep in mind; I'm financing the entire online project out of my own pocket, so agreeing to such terms makes no sense. 50 cents per month per tribal member is not enough to assist a fallen people in dire need of remedy in 2019. These Moors (Isaiah El, Atonya El, and undisclosed acting Trustee) don't have any and/or enough financial interests, etc. to make such a demand without logic and reason to support the changing of monthly dues. Again, Isaiah El has contributed 0.00 FRNs, Atonya El has contributed 18 FRNs, and undisclosed acting Trustee has contributed 27 FRNs since January 2019.

Bullet Point #2 – The cancellation of the automation via PAYPAL was discussed. I can agree not to utilize the automated system via PAYPAL, but logic and reason would have to support the change.

Bullet Point #3 – I solely control and have access to the website because I designed the website, wrote 90-95 percent of the content, and financed it, and continue to finance the website, from my own pocket. These Moors (Isaiah El, Atonya El, and undisclosed acting Trustee) are not webmasters, digital marketers, or content strategists and should not be meddling around inside the platform that I built with my own mind and hands to assist The People. I put too much work into the site for armatures to have access. I suggested I would teach any acting Trustee how to use the platform and write website content that speaks to The People. I don't have a problem giving anyone access as I could use the help in building out the member's portal for Tribal members to access. However, if you are not to be trusted (such as these Moors being discussed within this Affidavit of Fact and Statement of Truth) then you WILL NOT get access to this website... not on my watch!

Bullet Point #4 – Reread bullet points 1-3.

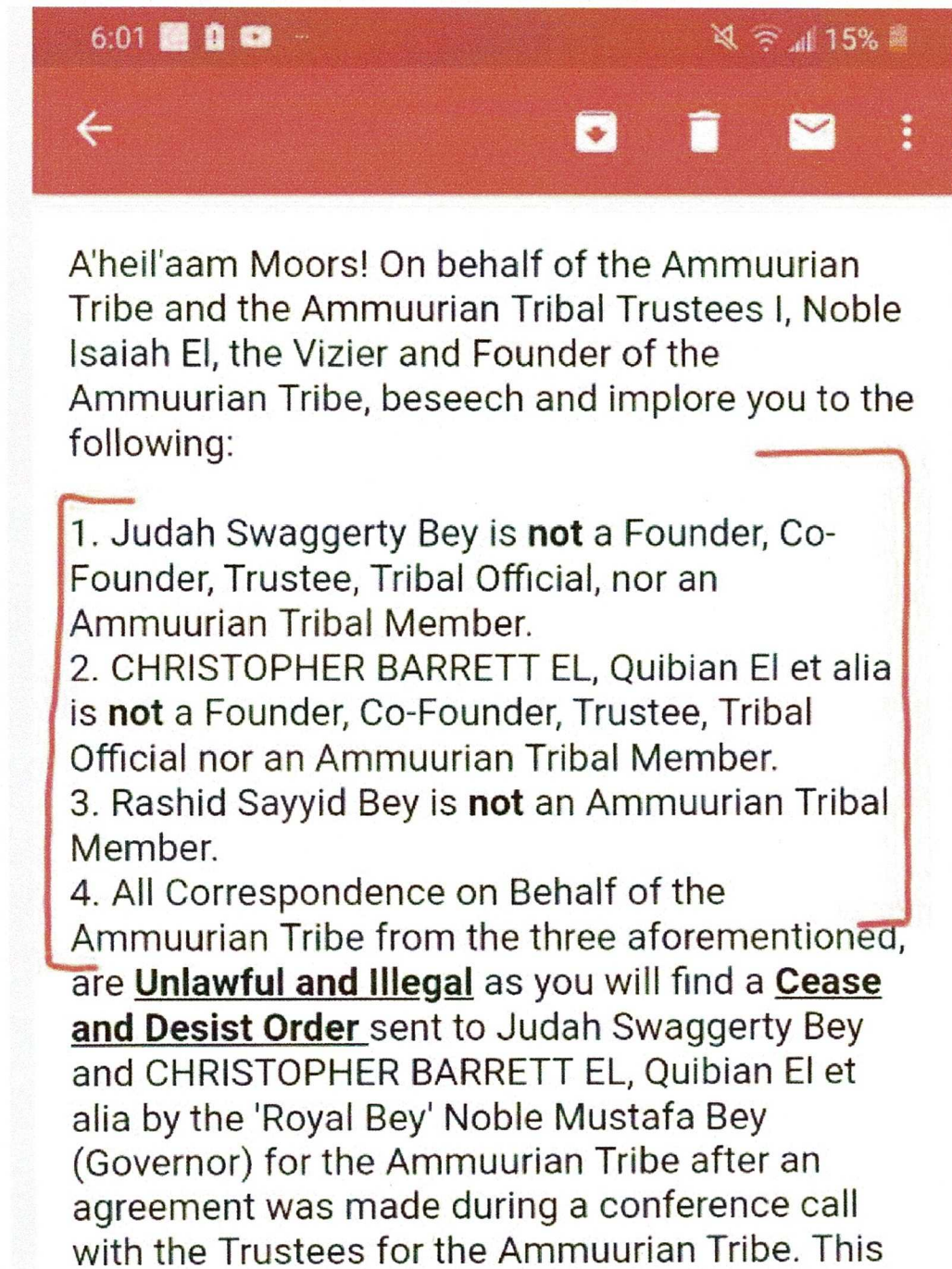

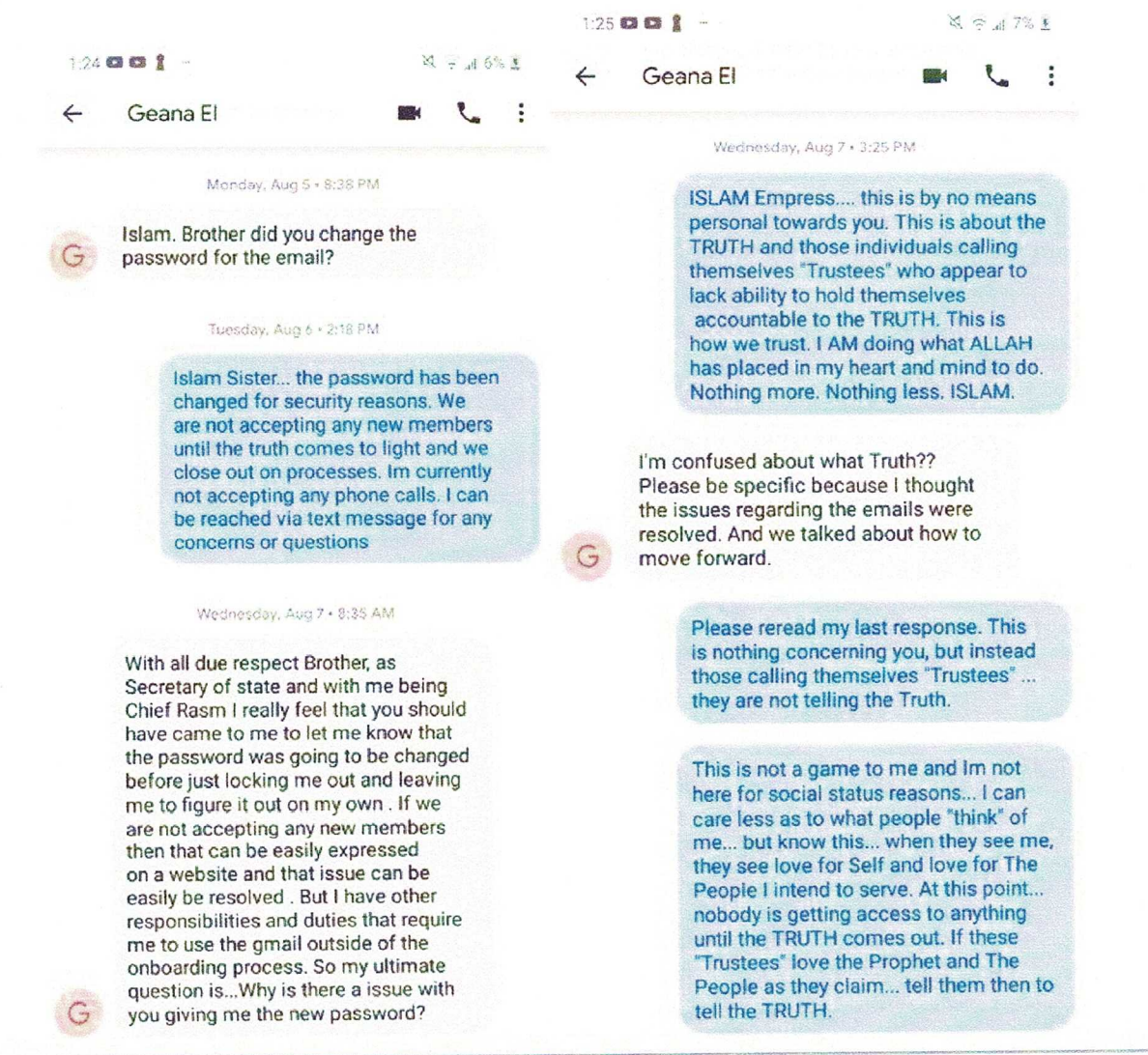

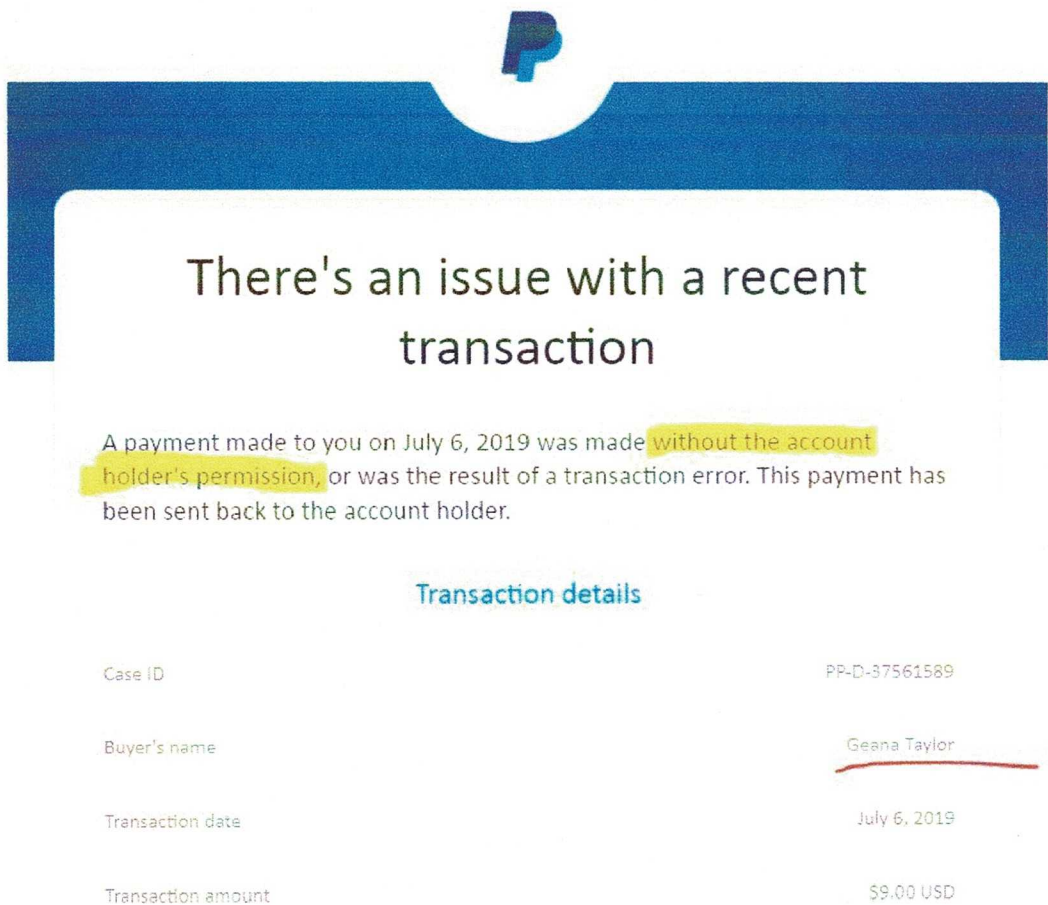


On August 5, 2019 I received a SMS text message at 8:38 PM Eastern Standard Time from Geana El. As you can see, in **Image #12** above, that my conversation via SMS text message would span a couple days. 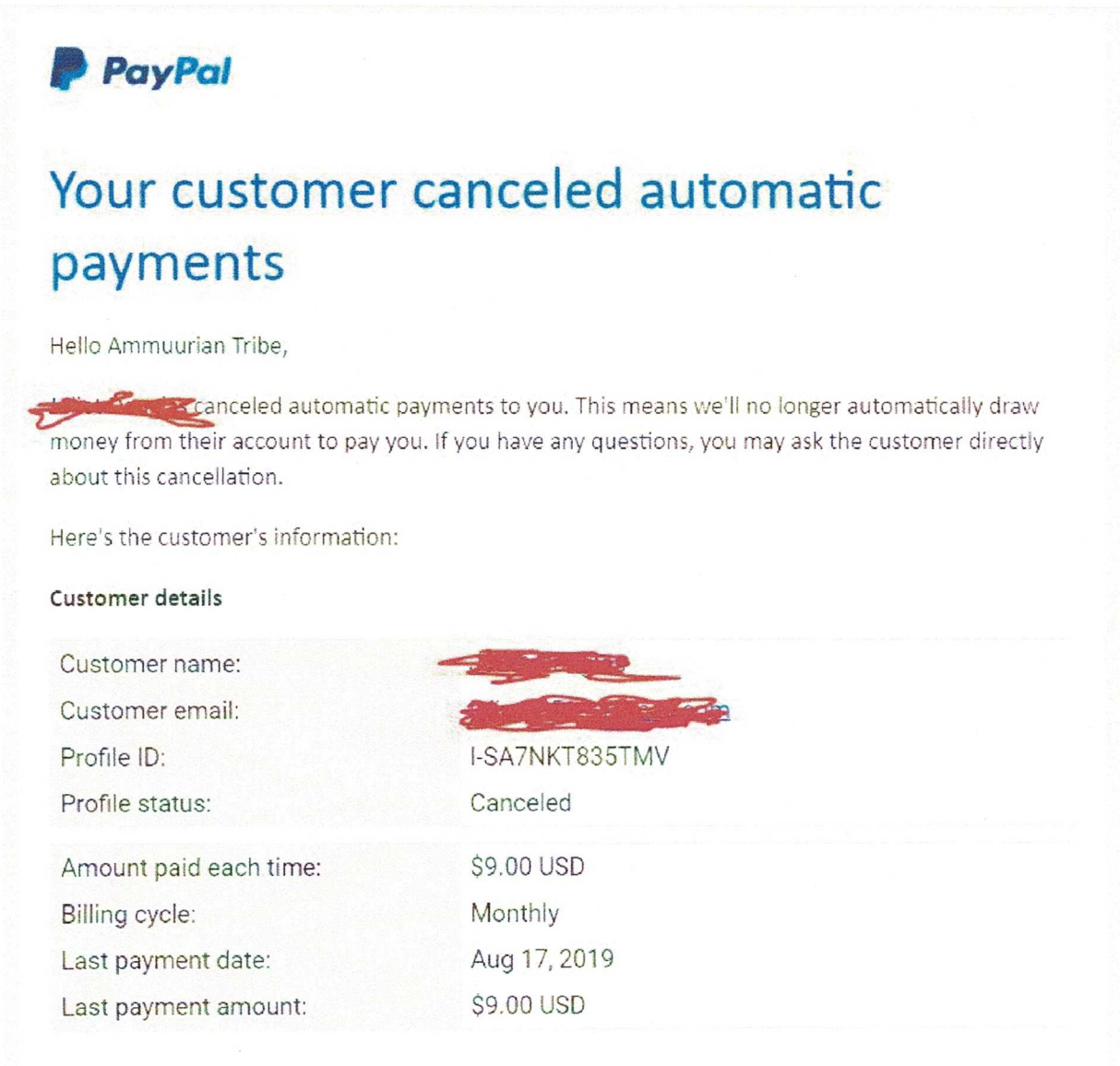
Also, the official Ammuurian Tribe gmail account is linked to all the online platforms that I personal control and fund with my own finances (Ammuurian Tribe website).

It appears that she went to PAYPAL to possibly file a dispute, this giving Geana's payment transaction on August 6, 2019 a Case ID #: PP-D-37561589. This could have been an attempt to try and shut the Ammuurian Tribe PAYPAL account down as certain acting "Trustees" wanted to dismantle the automation payment process. 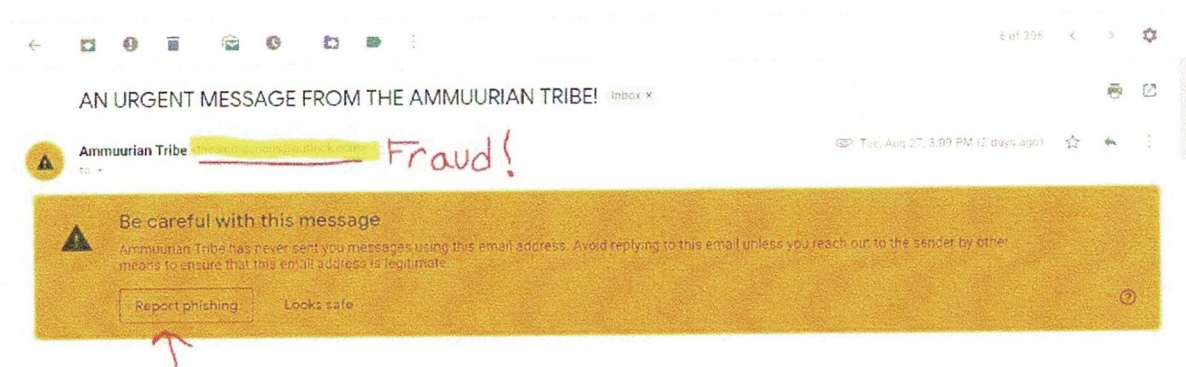
From this point forward, we are only accepting applications from tribal members located at Maryland Republic, District of Columbia and Virginia Commonwealth Territories ONLY!


