STATEMENT OF TRUTH AFFIDAVIT OF FACTS; CAUSE OF ACTION

NUNC PRO TUNC

I, Noble Quibian Naseer El, received an email August 13th 12:00pm with a letter titled (Cease and Desist Order) titled '*Notice of Estoppel and Relief Sought*' from Mustafa El Tarik Bey et alia Troy Franklin Bey, stating that I have 24 hours to immediately cease and desist, and lawful release of All journals, ledgers, book keeping entries, account logins, accounting, receipts, bank accounts, cash app accounts, PayPal Accounts, applications stored in my database, sign sheets, hard copies of applications, all payment profiles, (active, suspended and cancelled) Ammuurian Tribe Property (Projector, seals, Stamper, Embosser, receipt book and any other property in my possession) and that I annul all communication with current members immediately.

I, Noble Quibian Naseer El, as Co-founder of The Ammuurian Tribe, have an substantial amount of intellectual property, time, effort, funds, energy, etc., in '*Upliftment of Fallen Humanity*' invested into what is known as the 'Ammuurian Tribe,' by witnesses, records, receipts and documents, proving that I have and always have invested interest in the 'Ammuurian Tribe' along with Noble Judah Alhama Bey, who has secured, websites, social media accounts, PayPal, etc., himself in order to carry out Missionary/Eleemosynary duties as expressed on the Ammuurian Tribal Website, propagating the faith and to extend the learning and truth of the Great Prophet Noble Drew Ali to the Natural Peoples of the Land by The Prophet Holy Instructions. This unintelligible, unlawful command, and or claim coming From Mustafa El Tarik Bey et alia Troy Franklin Bey, bearing no Principle Signature, and not in accordance to 'Due Process Rules,' which is a consistent behavior with these particular members to include Isaiah El et alia Isaiah Boone El, where there is a reference to "Protocol," but the action of the "Protocol" administered by the Legislature of the Ammuurian Tribe, was never fulfilled and breached continuously. See (*First Clause of the Ammuurian Tribal Protocol*) Also without any cause to the release of my Position as Trustee and Chief Qazi, with no claim which will be stated in 'Exhibit IV,' offering no explanation to why I am being persecuted, defamed, slandered, etc.

"If a member / member of the tribe should find there is a breach of trust, breach of duty, the accusing member/ members should first discuss in person the matter with the member or members that allegedly breached the trust or breach the duty"

Exhibit I

From the week of June 9th- June 24th, 2019, Atonya El Et alia, presented a request to review the Pay-pal Account, and with no issue I met the request with access to the Pay-pal Account immediately, during this time a series of questioning from Atonya El was raised and answered to the best of my ability. A clear disconnect and or comprehension of how to utilize the 'Pay-pal' account and how the account was used to not only collect funds but also make purchases which all the purchases were made utilizing my Consort personal account. The method in which we all agreed that this will be temporary method from the Ammuurian Tribe conception, due to the "business clause" utilizing PAYPAL INC. platform requiring an 'EIN' to operate as Organization/Business, which was several notices from PAYPAL INC., demanding **Noble Judah Alhama Bey** (utilizing his Nom de Guerre/ Strawman) to give proof of "Tax Payer status" (recorded March 15th email correspondence see attachment #1), which was known by myself and **Isaiah El et alia Isaiah Boone El**, to find a resolve before **Noble Judah Alhama Bey** is subject to those penalties and or possible closure of the account for providing services to those members who have contributed to the Ammuurian Tribe. Furthermore, with the series of Probing from Atonya El, it became clear that there was an issue of mistrust towards me, by Isaiah El, and Atonya El, confirmed by a phone conversation on June 19th by Atonya El to my Consort asking of certain purchases that were made by me again utilizing my Consort account. For the record every purchase that is made I will send finance via PAYPAL INC., to my Consort 'Pay-pal' with corresponding information in the notes for the purchase, which my Consort will deposit into her banking institution, and then the Purchase will be made by me, and I will return with receipt of said purchase which is within the realm of what the Uplifting Fund was used for, by the contributions provided by the members. What was stated in a video created by the above-mentioned **Isaiah El et alia Isaiah Boone El**, was that a Signature sheet will have to be signed off before any purchase, which was not instituted until June 20th, 2019, 12:01(See Attachment #2)

Furthermore, on June 20th, during Trustee call meeting, I expressed my concerns of the matter of **Atonya El et elia, Isaiah El et alia Isaiah Boone El**, comprehension of the method being used, which was again implied that there was mistrust directed towards me. On June 23rd, I created a Tribal report concerning the 'Pay-pal' and those who have contributed to that account via cash-app, or in person transaction, which after submissions of the reports, more probing continued with implied intent of mistrust directed towards me, and confirmed communication of a transaction in person from an anonymous member (which stated he wanted to be anonymous) who has contributed 200 in Private commercial Paper and securities to me, which I only disclosed to **Isaiah El et alia Isaiah Boone El** as I felt the need to disclose to Isaiah El. During that conversation it was disclosed from Atonya El Et alia, that she knew about that contribution from Isaiah, which she confirmed by saying, "What about the 200 from Anonymous member." Again, only Isaiah, anonymous member, myself and Allah knew about that Noble contribution which was recorded and used for purchases concerning uplifting Fallen Humanity. At this point it had become clear to me that there was mistrust, and then proceeded to continue the call which at the time a Loan I provided, in the amount of 290.92 Private Commercial Paper and securities, to secure a Card machine in the amount of 565.98 which the Tribe from Jan-March 2019, only had available 275 Private commercial paper and securities, in the effort to not only provide Salvation to the Nation in the form of a De jure Nationality Card for the people and my kindred, which all parties was in agreement to that Purchase of the Card machine, which receipts are recorded and that it was agreed and stated by me that this is a LOAN, and I am willing to provide until I was able to receive my funds back at a later time for the record by multiple witnesses plus an Authorization sheet if my memory serves me well, I specifically wrote in the Notes in the body of the Authorization sheet that should be recorded by these individuals stating that the transaction was and is a loan having three (3) "Trustees" Sign the document on or about July 18th, (Request the Authorization Sheet from Isaiah El and also Reference the RECIEPTS in the email, you will find where I put in the notes that this transaction was for a "Loan" via paypal). Which an email correspondence sent by Isaiah El stating that I requested 200 back from a contribution that was given, which is yet again false and misleading. If that was the case, why not ask for all my funds back which is recorded and was given by me, via PayPal Reoccurring payments of 36 notes each month since January. What would be my incentive to mislead anybody about a Loan I provided since the purchase of the Card Machine, but also Note in the Pay-pal " Final payment for the loan provided by Q El & Sister Savannah El to purchase The Nationality Card Machine," (for 90 notes on July 27th) (or June 23rd for 200 Notes) "Savannah El & Q El loan given for the Card Machine" (Reference Receipts). In addition, to still be in accordance with Isaiah El, Mustafa El Tarik Bey and other "trustees" who was not Just and fair in the actions during that supposed mishap, and todays clear deceptive acts contrived by these Moors.

The Card machine was then in the care of **Isaiah El et alia Isaiah Boone El**, after shipment was completed to my domicile, Which my consort traveled to **Isaiah El et alia Isaiah Boone El**, domicile to give to him between that time frame of March-April of 2019, to start work on the De jure Nationality card for the Nation and the machine is in his possession until this day. During that call on **June 23rd**, it was disclosed to me that although **Isaiah El et alia Isaiah Boone El**, was with me during or in agreement to several purchases made, that even though we will talk about these purchases, he stated for the record "I never agreed to your open conversation about the finances," implying that he didn't trust my word. Furthermore, during the conversation which I thought that we was all in agreement to comprehension of the Reports I provided, I proposed that I will get partial of the loan in the amount of 200 Private commercial paper and securities back, due to some financial issues I had which I was in dire need of for my kindred wellbeing, which I was met with silence from Atonya El and Isaiah El. Then Mustafa El Tarik Bey commanded an answer for the proposition on the floor which was met with more silence from Atonya El and Isaiah El, which later Mustafa Confided in me agreeing how hurtful that was to hear silence from Isaiah El and Atonya El. For the record on the record and let the record reflect, I was in a place of "dis-belief" that these individuals who I have helped with my kindness beyond a tribal member just as a friend or more of kinfolk, to see that there silence in that moment was of clear disdain for my proposition or even towards my kindred, even during my predicament that I was in with my Children and Consort to have not only provide funds in the amount of 36 private commercial paper and securities as monthly contributions consistently, but also provide said energy in selfless actions, in hopes that the funds will comeback from the donations and or allodial cost collected from the people Non-members / Members which was agreed upon for the record, was met with silence in a moment of my vulnerability to these People I thought were my Kinfolk/Tribesman.

The call on **June 23rd** 2019, ended with an agreement to receive funds I loaned, but it was to be received only after I sign an Ammuurian Tribal Authorization sheet issued by **Isaiah El et alia Isaiah Boone El** on **June 20th 2019**, (**reference attachment #2**) via email, which I stated I will sign but allow me flexibility so that I can receive the finance for my kindred and will bring the sheet to be signed and recorded for the record on the Sunday Meeting. Finances was then sent from PAYPAL INC., to my Consort at 1:10 pm **June 23rd, 2019**. Without my knowledge there was another conversation in the early A.M hours of June 24th 2019, by Mustafa, Atonya, Isaiah, and Judah about me, taking the finances out at 10:10 A.M the day before when it wasn't agreed upon, and Accusations about the 'Pay-pal' Account which was stated that I was "stealing" finances from the funds and they needed Judah to confirm that was in fact true. Judah disclose to me a few hours later, which we all had an emergency call, pulling in Mustafa and Isaiah onto the call about the confusion about mistrust towards me again after I disclose the report the day before, further proving how wrong the accusations was and the clear breach of the "Protocol" referenced above. The recording of the Transaction on PAYPAL INC., says 10:10 am but its 10:10 am Pacific time, I sent payment to my consort account 1:10 pm Eastern time, which we cleared the confusion and confirmation was accepted at 12pm on June 23rd., but the ugly accusations of my Honor and Integrity even to this day is consistent with those initial probing, allegations, and accusations, which is defaming of my Character and required Cause of Action then and now which was not stated in the email nor video created by these Moors even more half-truths and lies. First an apology from Isaiah Via Text message for the mishaps, then a verbal conversation from Isaiah stating that he apologizes about what happen during that time frame, admitting that they were in fact mistrust towards me and that he experienced a similar case where someone was stealing at his Church, which was surprising to me for him to say "it came from someone that I least expected," which implies Isaiah El has not healed from the Church experience. In addition, he did mention that he will make it up to me and my consort as witness to the apology, which I did say via text message and verbally "all is forgiving" but later will prove that Isaiah El wanted me to forget. Never got an apology from Atonya El et alia.

The consistent basis of promises to close out activities that were made on the website to provide for the People continued with no clear structure from **Isaiah El et alia Isaiah Boone El**, starting with the Nationality Card Machine that was purchased in **March 3rd of 2019**, with the promise to have all the final insignia and or symbols to close the matter out and start distributing to members including myself who is in need of an instrument as needed for Earthly Salvation, and to no avail I am still without Nationality Card today. On **July 11th, 2019**, we met with an anonymous elder to enlighten us with the information to close out the De jure Nationality Card matter to distribute out to members. To no avail, the completion of the task was then designated to the "Chief Rasm," to finish the task of getting information from members to then distribute with no clear resolve from **Isaiah El et alia Isaiah Boone El**, or disclosure to me or to anybody what I thought to be the Trustees. The Ego that became clear to me that was taking place with certain members as oppose to being '*Societas Republicae Ea Al Maurikanos*' with no clear diplomacy and just some sort of a Hierarchy built on lies and deceit, to now charge Moors who have contributed 35 notes for a Nationality card which was previously agreed to supply cards to those after 90 days of

contributions and participation, which even more deceit and dishonorable which is a clear breach of contract..

Exhibit II

On or about the 18th of July, Trustee meeting, I was very vocal about making commitments and closing things out and having peace and harmony with the members and Trustees to move forward in accordance to Divine law. Within a Personal conversation with me by **Isaiah El et alia Isaiah Boone El**, days prior he discloses that has already put documents out on behalf of the Ammuurian Tribe, which I stated for the record on that call on or about July 18th 2019 that he made that Noble effort but has not disclose to the rest of the Trustees on what has been presented on behalf of the Ammuurian Tribe, which was then stated for the record by **Isaiah El et alia Isaiah Boone El** "If you don't want your stuff sent out, just let me know and I will not send" which I never implied that it wasn't a Noble effort in doing so, but more so of what are you presenting on behalf of the Tribe and shouldn't we all have a clear comprehension of such documents. The same sentiment was shared from **Isaiah El et alia Isaiah Boone El** On or about 20th of July stating for the record "If you don't want your stuff sent out, just let me know and I will not send" during Trust class, where it was a clear disdain for my questioning about what was presented which I still have not seen these documents yet again another Breach of Contract. Further explained in Exhibit IV.

The other reason behind the Questioning on my part towards Isaiah and what was clear to me was a more concerted effort for a "Moorish Ball," which was not agreed upon before presented to the Public, as oppose to closing out other action steps to provide Salvation to not only myself but for those who was in need of Salvation and looking forward to the Success of the Tribe. It had seemed that we would start one project and bounce to the next project before the previous project was completed if those would remember "Read Moor About it" started and was never completed. I was also a witness to the same practice of unfinished projects with other positions in the tribe and no clear communication and when a claim arise against me and my consort where slander was accepted and unwarranted, unconstitutional recordings was presented without the consent of my Consort and myself, infringing on our secured Rights by the Organic Constitution 'Forth Amendment', And again met with Silence when I proposed that it was unjust, and unethical by the same parties. I find that later it was disclosed to me by Mustafa El Tarik Bey that obviously it was met with silence because I was being recorded without my consent previously with previous allegations/accusations in June of 2019, by Atonya El and Isaiah El. In addition, there were numerous stories disclosed to me and others about unsolicited recordings made by these individuals when they were in Church against their Pastor, and recordings against 2 or more trustees in the past. Mustafa even made reference to me about how the de facto in an unlawful charge against "unconscious" Moors, but with the De Facto unreasonable search and seizure they did find evidence that the "unconscious" Moor was committing a crime of distribution of drugs, making references that I was in fact guilty of some erroneous charge by the "Trustees" where I provided full reports of all transaction from PAYPAL INC., CASHAPP INC etc., on August 1st. (see attachment #3), also was told by Mustafa, that my words change so much on the matter that it was still an assumption/accusation that I in fact couldn't be trusted due to the "changing of my words." Which still does not explain why haven't a meeting taken place to breakdown the finances when it was question, why all the secrecy and accusations? Why not have a conversation which I suggested on several occasions, which I suspect, that it was not about whether I was in breach, it was more concerted effort to remove Judah and myself for some ulterior motive.

Exhibit III

On or about the 18th of July and the 1st of August, they were more Trustee meetings taking place in person and via conference calls. During those conversations it was highly suggested that we "reset" and "revamp" the Ammuurian Tribal Finance and that we use an "Allodial Account" utilizing a "Banking" Institution through a method and process Isaiah has supposedly completed himself which I never seen proof of such claims, which I was in accordance with, if in fact that it was true that we can have an "Allodial Account" with a "Banking" Institution because of the state of affairs involving my Consort account and Brother Judah which both were using there 'Strawman' to secure Tribal affairs. Also, what was suggested that what we had offered on The Ammuurian Tribal website was not in accordance to what the Prophet had specific instructions for dues or the collection of Uplifting funds and that the website and what we have been presenting the Past 7 Months was not in alignment to that and that there is grounds for 'Fraud.' The wording on the Website stated that "Monthly Dues shown above is your monthly Obligation for Moorish National Taxes." When I pose my question about what was stated and needing clarity to which part of the statement was considered Fraud, and how can we correct it. Which the answer from Isaiah was that the obligation to the Moorish National Tax was not correct, with no other information to qualify that answer. The concerted effort was expounded upon even further

about moving forward to assist only Moors that were near this territory all though a majority of those contributing were from other territories across Morocco which "Trustees" made mention that "If I cannot see you in person and shake your hand look you in your eyes you are not a member." Which I stated, "what should be done with those contributing members?" Which Mustafa mention "Don't cut your nose off despite your face," because it was suggested that we move forward with no dues, but we will not be able to afford the website, conference room just in case attendance were low, and other expenses, etc. Referencing Mustafa El Tarik Bey statement, these folks have contributed, and we cannot cut them off completely, and some sort of relief and remedy will be offered for the fact of abandoning them. In addition, what was also mentioned by Atonya El was that the finance balance is a "Cushion for us." Which the opposite was shared in the video created by these Moors stating that me and Judah intention was only for the finance. For the record I was not agreeance with these changes and acted accordingly due to the constant confusion on the part of these individuals. It was always a battle about Basic Membership with Isaiah El and others, in which we allowed Moors to become members without the support of finances, but any Paperwork needing seals would have an allodial cost due to the administrative cost. On many occasions it was said "Basic Memberships is allowing Moors to get remedy for free and we shouldn't have a basic Membership," keep in mind the "Vizier" Isaiah El has never contributed any finances himself, yet again clear breach.

For the record on the record and let record reflect, as a Contributing member to include my Consort, to push the Ammuurian Tribe, I have contributed 288 private commercial paper and securities in monthly automation reoccurring dues consistently (recorded), I have also loaned the Ammuurian Tribe 290.92 private commercial paper and securities (recorded) also contributed weekly 20 notes to the conference room. Brother Judah Alhama Bey has contributed 633 in private commercial paper and securities for the past 7 months since the official publishing of the Ammuurian Tribe. For the record All Parties mentioned above **Isaiah El et alia Isaiah Boone El, Atonya El et elia, and Mustafa El Tarik Bey**, has contributed a total amount of 63 in private commercial Paper and securities and was not consistent with those contributions in private commercial paper and securities to include the Isaiah El which has not contributed any finance out of the 63 noted above. All contributions for current members, active, not active, and not including the parties mentioned **Isaiah El et alia Isaiah Boone El, Atonya El et elia, and Mustafa El Tarik Bey**, has contributed to all items purchased, publications, all items used to assist with Uplifting Fallen Humanity as expressed (See Receipts). Furthermore, what was not provided and what was on hold for months for reasons unknown (but became clear later to me) was processes, to successfully "vet" out who are current members that were near other territories, due to lack of communication. For the record all points were not fulfilled and Fulfilled as published:

- Access to private Tribal Member area (Not fulfilled)
- Weekly and monthly educational conference calls (Fulfilled)
- Team leaders to help guide your journey (Not Fulfilled)
- Proven communication formula that gets results (Not Fulfilled)
- Writ and Affidavit templates for lawful remedy (Not Fulfilled)
- The support of the Sovereign Nation behind you (Fulfilled)
- Community of like minds who understand you (Fulfilled)
- Access to Ammuurian Benefits Programs (Not Fulfilled)
- Business opportunities and educational lessons (Not Fulfilled)
- The support of an Allodial and De jure society (Fulfilled)
- A chance to work within the tribal government (Not Fulfilled)

Referenced above are what was expressed to the public on the Ammuurian Tribe website and was not fulfilled and fulfilled, the focus being "not fulfilled," which put us in a place of deceitful practice, if after 7-8 months these "Officials" allowed the Website to reflect that without the subtle changes that were needed or proper "vetting," of those members who have contributed to the Ammuurian Tribe. My questions even to this day is "Why the subtle change, and why haven't this come up sooner so that we can make the proper adjustments before all this events in Month 7 since the conception?." to include the question on the Nationality Card which was expressed and recorded on several classes (conference calls) since the Card Machine was Purchased. Which is consistent with unreliability by those parties mentioned above. I place myself to blame and responsible for entrusting the above mention Moors in completing the duties to include Isaiah El whom is on the Website as "Vizier" leading the charge of Uplifting Fallen Humanity on behalf of the Ammuurian Tribe which we agreed to present him as such, as we bought into the unreliability, deception, lies, and overall negative spirit of it all.

On August 15th, Noble Judah Alhama Bey sent me correspondence (See Attachment #4) from Mustafa El Tarik Bey et alia Troy Franklin Bey, this was after August 13th "Estoppel letter," Stating *"I also desire an explanation as to why some emails relevant to the Cash App, apparent*

PayPal transactions and Trustee to Trustee and Trustee to Various Tribal members correspondence were deleted from the contact correspondence via the Ammuurian Tribe Website, that you limited and controlled the access to. Just to be Crystal clear, While the email deletion was taken place multiple Trustees were in the account and viewed this deletion real time, as this unapproved and suspicious action was taken place." For the record on the record and let the record reflect, All correspondence to the Ammuurian Tribe email from CASH APP INC., PAYPAL INC., and or accounts from both entities are ACCOUNTED FOR and Provided to Mustafa El Tarik Bey et alia Troy Franklin Bey and Isaiah El et alia Isaiah Boone EL and other "Trustees" on August 1st 2019. As the acting Treasurer I was never provided receipts for Conference room and or Masonic lodge Trip that I lawfully requested several times to no avail. Furthermore, another correspondence from Mustafa El Tarik Bey it was agreed to have a conversation to settle the matter between Mustafa, Isaiah, Judah and myself on August 15th at 8pm, to address the issues, as I had concerns of unsolicited recordings in the past by these Moors, I immediately stated "I do not consent to any recordings however contrived by the likes of you as it is a violation of my Rights secured by the Constitution, it is unethical, and violates Divine Principles." To no avail it was stated that another party was taking the minutes and recording the call, which I vehemently disagreed. I am not sure if the immoral act continued but I do not put it pass these Moors who consistently violate Divine and Natural Law. During the call I explained the confusion that caused the allegations/accusations that continued to be made by these parties that everything is recorded, and everything is accounted for, so what is the issue and why are they continuing to persecute me and come up with accusations. To no avail it was said that "You changed your words on several occasions," regarding the 'Paypal Account,' 'Cash-App' Account etc." but no evidence was ever presented. And even in the event why not present to your dear Brother each call, class etc., are started with the reading of 'Moorish Holy Temple of Science Koran' Chapter 25 'Holy Covenant of the Asiatic Nation.' Furthermore, during the call I asked Isaiah El "What was the apology for the first accusations and allegations committed on June 23-24th for," which he read scripture from the Bible and was stated it was because of "love." I then asked for the record "what did you apologize for specifically," to no avail was met with more silence. Which Isaiah mention in the video but only offering the explanation that it was about the confusion in when the funds was taking but not the conversation with Judah, Mustafa, and Atonya accusing me of stealing. During the Call there were also talk of interest into the Ammuurian Tribe Conception, between Judah, myself and Isaiah where it was stated by Isaiah that he never agreed with the '9-18-36' notes for dues, where Noble Judah, was vehemently in "disbelief" that Isaiah would lie and say he was not in agreeance with the dues which he offered an explanation that "When you're in a Quorum of 3, it's the majority that decide," Which was not True, we all agreed that it will be the amount for the dues, and if it was an issue, why leave that amount available for months.

I stated for the record many times during that call, that whenever an issue or a contradicting statement from Isaiah would arise, that Isaiah would either lie, deflect, or move the proverbial "Goal Post," for himself consistently with no accountability. Furthermore, I ask the Question about the Ammuurian Tribal Protocols, 'Divine Constitution and by laws' etc., Stating that "Did any of you ever follow these rules and procedures that were in place" which he stated "No, 100% No." When I posed the question about whether Isaiah El mistrusted me, to no avail met with silence yet again. Which later led me to the discussion about the "Estoppel letter" sent by these Moors being unlawful, and why, because none of these Moors ever offered any Due Process to any of the claims, and accusations etc., also the interest that was put into the Property purchased by those members who have contributed consistently for months to include Noble Judah, Myself Bearing receipts and records via PAYPAL INC., CASH APP INC. It was clear to me that these Moors are in a place of mistrust and I am concerned that we are being deceived via fraudulent practices by these individuals and clearly willing to use any means to deceive everyone and in addition, none of these parties have never took the time to hear or allow Due Process to take place, and that it wasn't about whether the accusations were true, it was to deceive others to include Judah and myself in keeping property that does not belong to them, which is still presently in the possession of these Moors, and then send fraudulent Letters demanding the return or turn over accounts that does not belong to them. I ended the call and said we will have to have another discussion on another date.

On August 27th email correspondence was received by Ammuurians@outlook.com. "BE AWARE: Our original email, website and social media platform have been compromised, The Ammuurian Tribe is no longer affiliated with the creators of the original website, email and social media pages." To include the now selling of the Nationality Cards for 35 private commercial paper and securities which was never discussed or agreed upon and was supposed to be provided to those who have contributed their monthly dues. 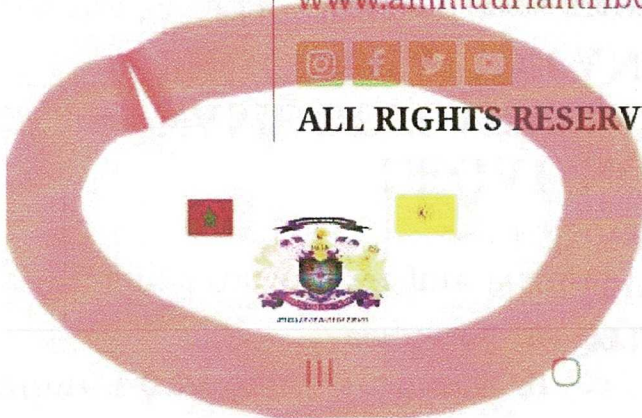

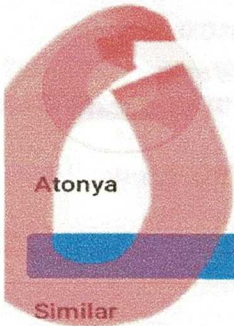
